

Submission of original bid security must be delivered at the office of the Director Finance and Accounting, Procurement Department, Office of the Clerk- Lodwar. Prices quoted must remain valid for one hundred and twenty (150) days from the opening date. The bid security must be valid for one hundred and fifty (150) days from the opening date.
