COMMUNICATION FROM THE CHAIR

T. Speaker: Good morning Honourable Members. Honourable Members as you are aware, the County Executive submitted the Turkana County Integrated Development Plan (CIDP) Third Generation 2023/2027. The same was committed to the Sectoral Committee on Finance, Planning, Trade and ICT on 16th May 2023. The Office of the Clerk in Liaison with development partners, that is UNICEF, UNDP and RCK have organized an unpacking exercise of the County Integrated Development Plan Third Generation. Their main objective of undertaking this exercise is to ensure that the Members of County Assembly understand the priorities and objectives set out in the five-year plan for the County and more so the development priorities in their respective wards. In addition, it is anticipated that these will help strengthen the engagement between the Members of County Assembly and their constituents as their concerns and needs will be addressed. Honourable Members, it is important to note that this exercise will foster collaboration between the members of County Assembly and other stakeholders in their respective wards; thus, effective and coordinated development support.

Honourable Members the Turkana County Assembly Standing Orders No. 47 (1), relating to Messages from the Governor provides; the Speaker shall read to the County Assembly any message from the Governor or the Senator of the County delivered to the Speaker for communication to the County Assembly.

Honourable Members pursuant to provisions of standing order number 47 (iii) (c), I hereby refer the message together with curriculum vitae of the nominee to be dealt with by the Committee on Water Services, Environment and Natural Resources. Honourable Members the committee shall consider the nomination and table the report in the County Assembly for debate within 21 sitting days from the date in which the Committee first sits to consider the nomination in accordance with section 9 (i) of the Public Appointments (County Assemblies Approval) Act Number Five of 2017 and County Assembly of Turkana Standing Orders. It is therefore important that the Committee embarks on the vetting exercise to enable speedy conclusion of this task within timeline set by the Public Appointments (County Assemblies Approval) Act Number Five of 2017. PROCEDURAL MOTION

T. Speaker: Yes, the Honourable Leader of Majority, Honourable Stephen Edukon Proceed.

Hon. Edukon: Thank you, Mr. Speaker, I rise to move the procedural motion that pursuant to standing order 33 chapter 3, this County Assembly do now adjourn until Tuesday 20th June 2023 at 9:00 a.m. in accordance with the County Assembly Calendar.
